S.A. 1.2.1 AMIF Title: Early identification and immediate referral of Trafficking of Human Beings

Indicative amount: EUR 4 million **Type of partnership:** Group of MS

Description of the SA:

The specific actions should include all aspects accelerating and facilitating the early detection and identification of victims. This includes training activities for frontline officers (law enforcement, border guards, immigration), for mental and health care practitioners, social workers, educational personnel; capacity building, especially the creation of special units within competent authorities or civil organisations to deal with trafficking in human being and setting up an adequate IT infrastructure for the timely exchange of information on potential victims, perpetrators and cases. It may also include the establishment of a single register for the registration of victims to avoid double-counting. The action may also serve to set up or strengthen the national referral mechanism.

S.A. 2.4.1 AMIF Title: Services for victims of Trafficking of Human Beings for non-EU nationals

Indicative amount: EUR 2 million Type of partnership: Group of MS

Description of the SA:

The specific action will focus on the provision of services for victims, who are non-EU citizens. This includes physical and mental health services, counselling, translation and interpretation services where appropriate, material assistance (e.g. food, clothing and other in-kind support), legal assistance, cultural mediation, education, job counselling and training. Activities under this action can also include specific services for child victims of trafficking in human beings, such as individual assessments, access to education and appointment of a legal guardian for child victims if relevant. The specific action should promote a multi-agency and cross-sectoral approach. In addition taking into account the gender dimension special assistance measures should be available for vulnerable groups, such as children, people with disabilities, LGBTQ+ people.

This action is intended to give effect to the EU Strategy on combating trafficking in human beings and support the implementation efforts of the Member States. This action should complement the national programs in terms of victim support, notably while Member States are required to establish shelters for vulnerable victims, other victim support instruments and services may be financed under this specific action.

Description of the SA:

The eligible period of the European Return and Reintegration Network / ERRIN Programme will officially end on 30 June 2022 and the activities developed and implemented under the Programme will end on that day. There are tasks and responsibilities that will need to continue until 1 October 2023.

The activities are

- the completion of reintegration assistance to returnees who entered the Joint Reintegration Services under Programme after 30 June 2021 and until 1 July 2022 and who remain legally entitled to a full year of reintegration assistance by a Service Provider;
- activities required from a legal and a financial management point of view to bring the ERRIN programme to an official closure, and
- activities to assist Frontex with the first phases of the implementation and the fine-tuning of the activities taken over from ERRIN.

Description of the SA:

Given the very frequent absence or unreliability of identity documents of the asylum seekers, Member States need effective tools to identify quickly the country/region of origin of asylum seekers, which is a very important factor in the examination of asylum claims. At present authorities spend considerable time and effort investigating the identity and country of origin of asylum seekers, based on their declarations. Traditional language analysis is already used to clarify the spoken language, and hence the country of origin. However, the process is cost intensive and time consuming, sometimes requiring weeks or even months. In cases of a mass influx of asylum seekers, the capacity limits of language specialists are reached quickly.

The development of modern language assessment tools (based on new technical developments facilitating the analysis of languages and dialects, as well as on the exchange of samples and the sharing of expertise between Member States) and their widespread use at a European scale could substantially reduce the authorities' efforts and shorten the time needed for the examination of asylum applications. Such tools could make asylum procedures faster, less resource intensive and more effective. Faster asylum procedures could enable a reduction of the existing backlogs and savings on the material reception conditions (which would be provided for a shorter period). The specific action aims to develop and implement a common process for language indication and analysis that would be accessible to the EU+ countries. Within this process, the advantages of automatic language indication would be combined with the benefits of human language analysis, providing 'fast track' and 'full track' language indication
